### **Parish Council Vacancy Parish of Eynsham**

As requested, I enclose the “Notice of Vacancy” in respect of the above. Please display it in the area by no later than the date shown on the Notice. As you will see, the Notice gives the date by which any request for an election has to be made and, obviously, we will let you know if an election is to take place. Please note:

- (1) that ten separate requests are not needed – one letter signed by ten local government electors for the Parish would be sufficient;
- (2) that if an election is not to be held, the law requires your Council to co-opt a person to fill the vacancy “as soon as practicable after the expiry of the period of fourteen days”; and
- (3) that, if an election is requested, I will supply further information about the elections process.

There are three further points which are applicable should this process result in your Council being required to co-opt:

- (1) the National Association of Local Councils has produced a briefing note relating to co-option (Legal Briefing L15-08). This is available from the Oxfordshire Association of Local Councils – Tel: 07746 943076 or 07519 367709 or email: [info@oalc.org.uk](mailto:info@oalc.org.uk);
- (2) it is **essential** that any person co-opted is (i) qualified to be a member of a Parish Council; and (ii) is not disqualified. The qualifications and disqualifications are explained in Part I of Guidance produced by the Electoral Commission, available at <http://www.electoralcommission.org.uk/i-am-a/candidate-or-agent/parish-and-community-council-elections-in-england-and-wales>. Although not a statutory requirement, you may wish to ask the co-optee to confirm to you in writing that he/she is qualified and not disqualified; and
- (3) Once you know who is going to be, or has been, co-opted, please let me know their name and address and the date of the Parish Council meeting which will approve, or has approved, the co-option. I will then supply information about the code of conduct and the required registration of interests, and the necessary declaration of acceptance of office.
