10/20 Apologies – were received from Cllr Mrs Hughes, Cllr P Staley & Dr F Wright.

10/21 Declarations of interest from Councillors – there were no Declarations of Interest.

10/22 The minutes of the meetings of 4 May 2010 It was **RESOLVED** that the minutes be signed as a true record.

10/23 Public Participation – District Cllr Mrs Stevens gave details of the Committees to which local members had been elected.

10/24 Clerk's Report – the Report was noted.

It was agreed to place a notice to the door of the Council Chamber saying “this door is closed to the cold not to you”.

Cllr Andrews gave an update on the trees at Dovehouse Close. Quotations will be obtained for the removal of selected large trees up to the budgeted amount. All the trees in the area could be coppiced. Cllr Andrews suggested that future projects should be managed so as to keep delays to a minimum.

10/28 Council Vacancy – It was agreed that if a Poll was not called, to advertise the vacancy requesting applications and to consider these at the July Council Meeting.

10/29 Provision of a seat in the High Street

It was agreed to look at the price of placing a fold up plank/seat in the High Street.

10/30 Worton Farm –

Dr Wright had circulated a report which was noted.

Flood Area – District Cllr Mrs Stevens will ask the District Council if they have produced the flood map. The Environment Agency have recently issued an updated map showing that the southern fields flood. It was agreed that the Clerk will also write to Andrew Tucker, District Council asking what steps of mitigation would be taken as part of the Bitterell planning process to take it out of the flood risk area.

The police had requested a sub-lease. In principle there was no objection, but the Council would firstly like to see the lease.
