## **MINUTES**

15/235 Apologies for absence – Mr G Beach, Ms S Brown.

15/236 Declarations of Interest - None.

15/237 Minutes of the meetings held on 1 September 2015 – It was RESOLVED that the minutes be signed as a true record.

### 15/238 Public Participation.

Residents, George Smith, Kate O'Neil, Ian Middleton and Rosemary Parrinder expressed concerns about the evidence base for the proposals for the A40.

15/239 The Council heard a presentation by officers, Lisa Michelson and Odele Payne, of Oxfordshire County Council regarding the proposals for improvements to the A40. A public consultation is due to take place in various locations over the next few days. The presentation is being publicised via Eynsham Online. The council hoped that residents would take the opportunity to attend the consultations.

#### 15/240 Correspondence -

- Mr Ross Macken it was agreed to allow Mr Macken to reposition the bench.
- Mr Norman Ashworth traffic issues at entrance to Willows Edge at school collection time.
  The Clerk to contact the school expressing concern regarding inconsiderate parking around the school and to enquire if the school has a journey plan.
- 20 mph: A number of responses had been received with regards to the 20mph proposal. The vast majority were in favour of the reduced speed limit. Councillor Mathew informed the council that the full costs of this project would almost certainly have to be met by the Parish Council. The council discussed whether the limit should cover the whole village and agreed that this would present a clear and consistent message. Further investigations required to find out the process.

**15/242 Finance** – It was **RESOLVED** to pay the accounts as presented. The income & expenditure reports were noted.

15/243 The council RESOLVED to co-opt Ross Macken to the council.
